AN UNEMPLOYED MEMBER IS CATEGORISED AS A PERSON QUALIFIED TO BE EMPLOYED IN, AND SEEKING TO BE EMPLOYED IN, AN OCCUPATION THAT WOULD MAKE THAT PERSON ELIGIBLE TO BE A MEMBER OF THE UNION.

As an Unemployed Member you are granted all the rights of other members. You will receive the Union's regular publications and have access to a range of commercial discounts and services negotiated by NTEU on behalf of members. You may receive industrial services and can vote in NTEU elections.

If you return to work in the tertiary sector please contact NTEU immediately in order that your membership can be transferred back to the ordinary member category.
